## Introduction

**Education, Health and Care Plan (EHCP) Referral decision:** Following a request for an EHC needs assessment, or the child or young person having otherwise been brought to its attention, the local authority must determine whether an EHC needs assessment is necessary. The local authority must make a decision and communicate the decision to the child’s parent or to the young person within 6 weeks of receiving the request.

**Assessment decision:** Following an EHC needs assessment, the Local Authority makes a decision whether or not to develop an EHC plan.

The whole process of EHC needs assessment and EHC plan development, from the point when an assessment is requested (or a child or young person is brought to the local authority’s attention) until the final EHC plan is issued, must take no more than 20 weeks. Where there are exceptional circumstances, it may not be reasonable to expect local authorities and other partners to comply with the time limits above. The Special Educational Needs and Disability Regulations 2014 set out specific exemptions.

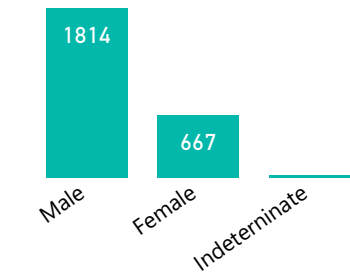

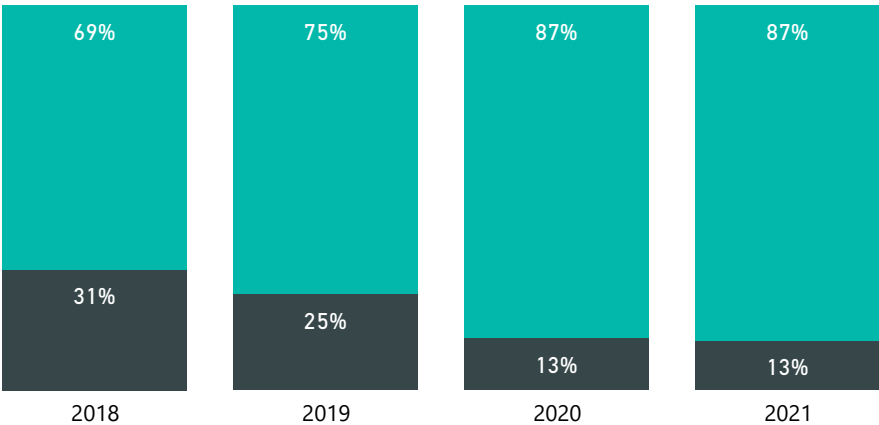

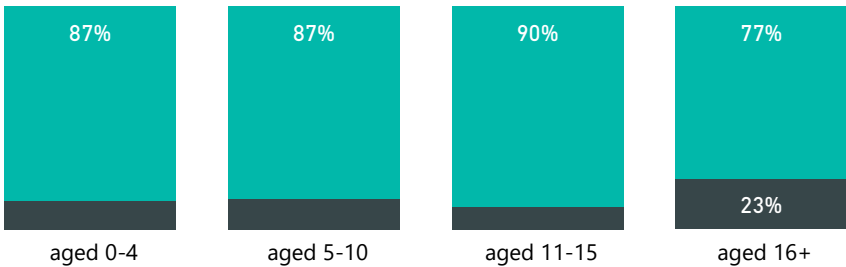

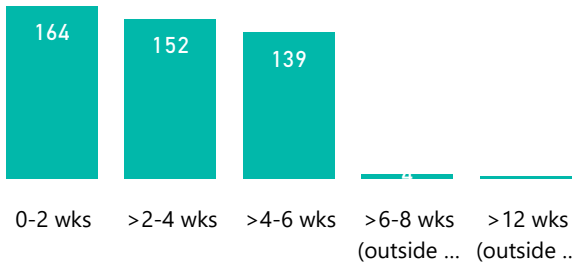


Completed EHCP Referral Decision 2021 (new clients). Age at date of referral.

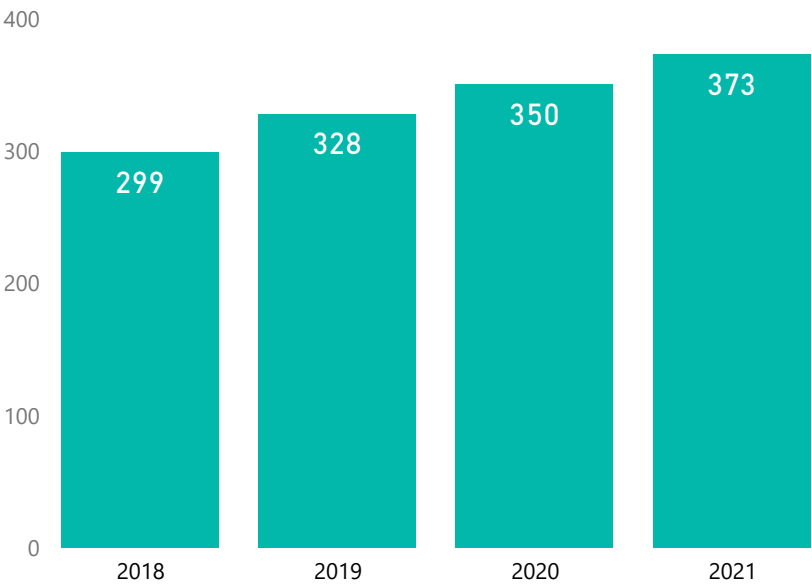

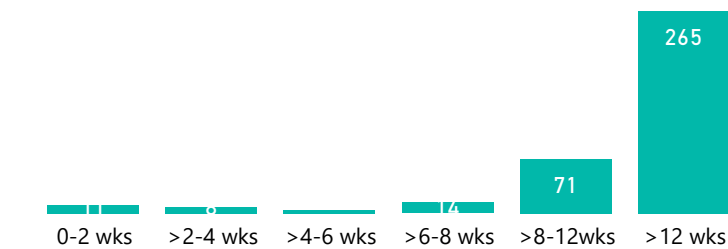

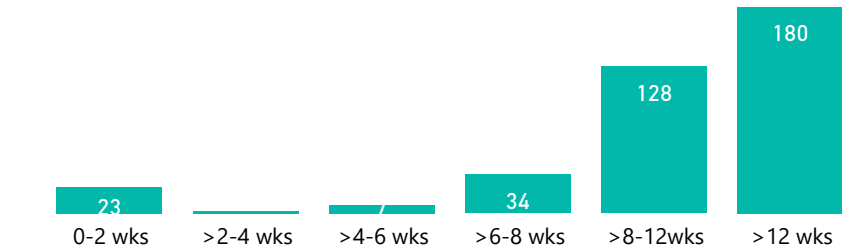

Time between referral receipt & decision whether to issue EHCP, 2021

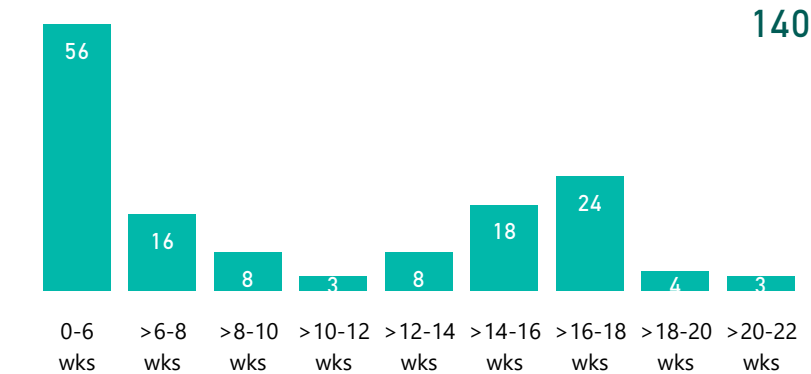


Time between decision to assess & decision whether to issue EHCP, 2021

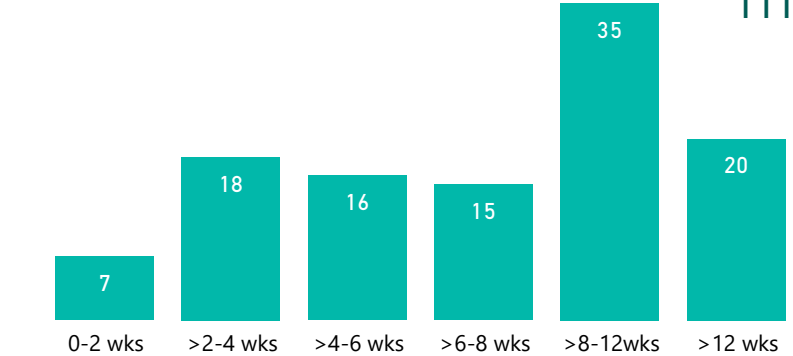

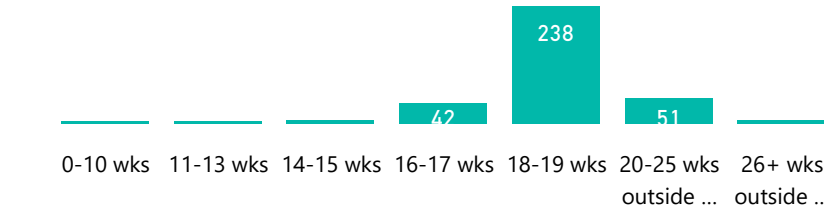

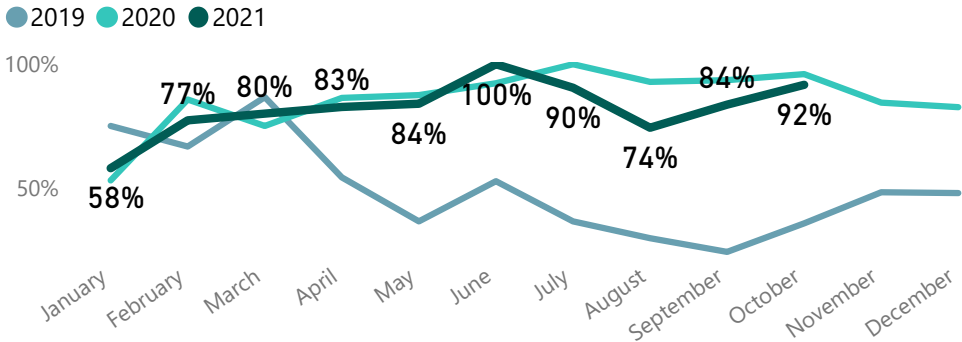

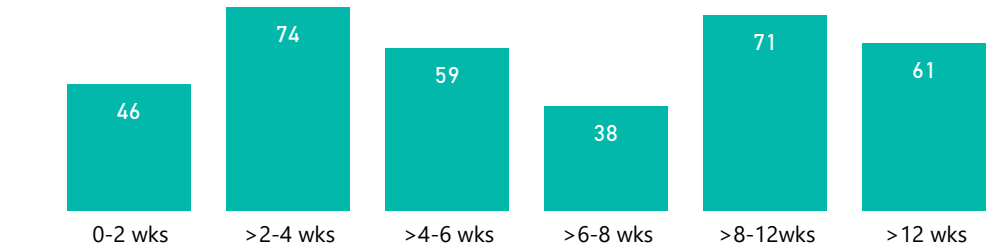
Time Between Referral Receipt & Issue of EHCP (new clients), 2021

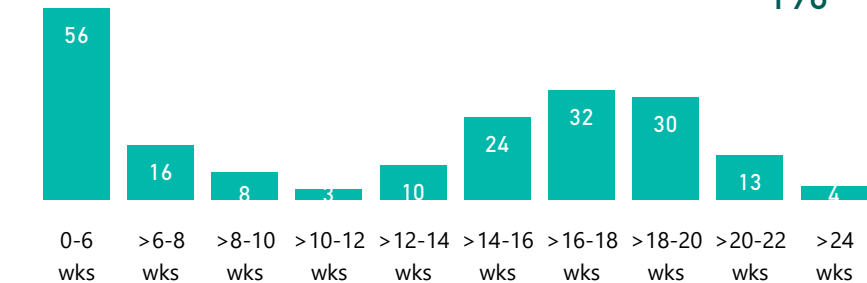


Time Between Decision to Issue & Issue of EHCP (new clients), 2021



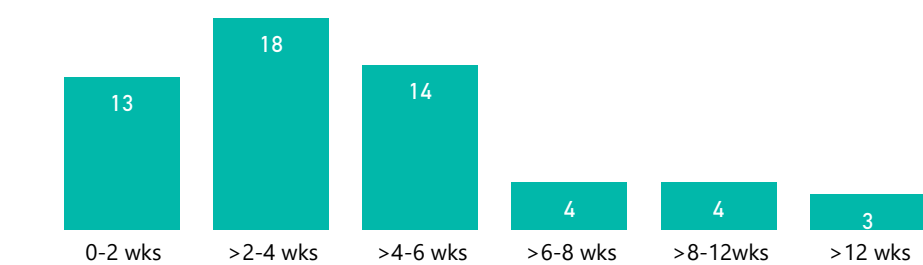

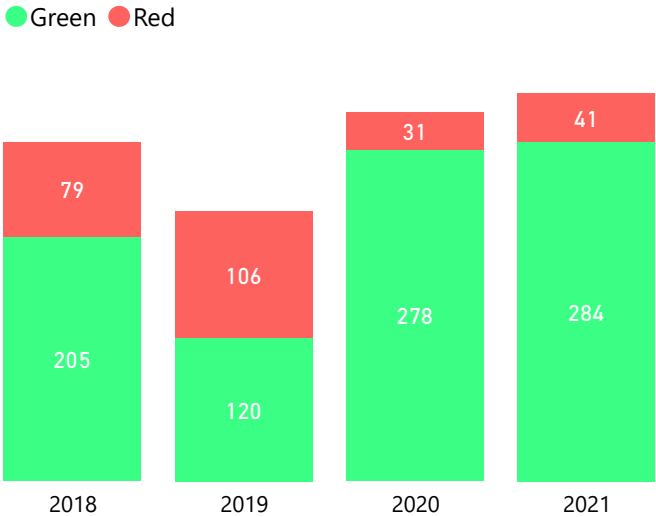

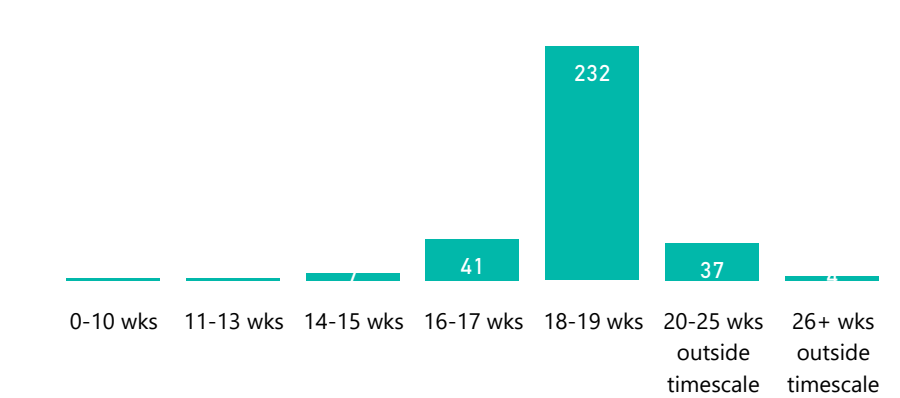

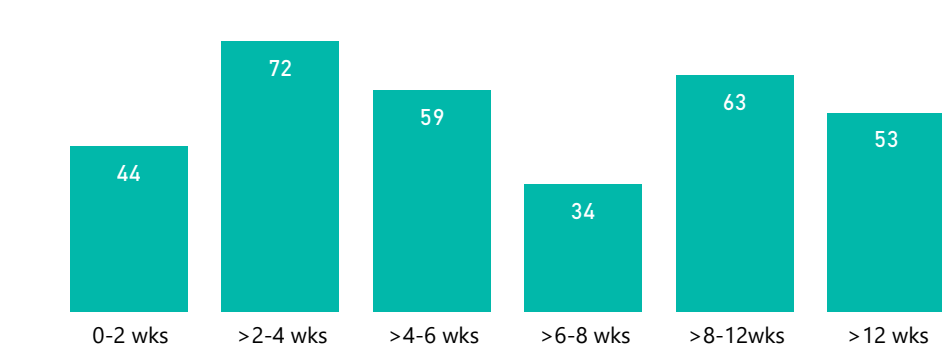

Time from the decision to issue a plan, to the issue of the EHCP (new clients), 2021

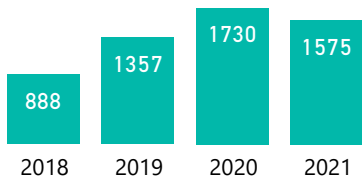

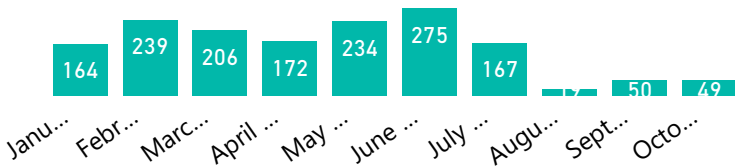

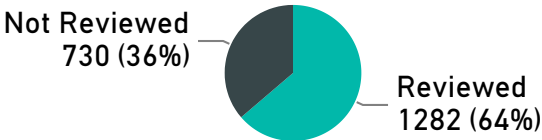

Overdue Reviews: Status determined by the length of time since the last Review/Issue of EHCP



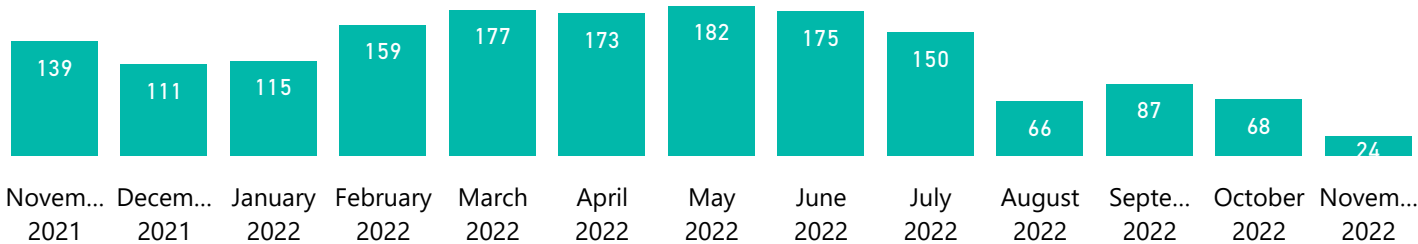

If the time since the last review/final EHCP completion extends beyond 14 months, they are counted as 'overdue'.

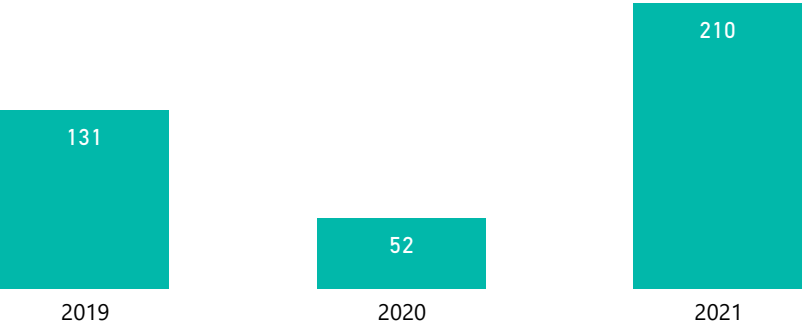

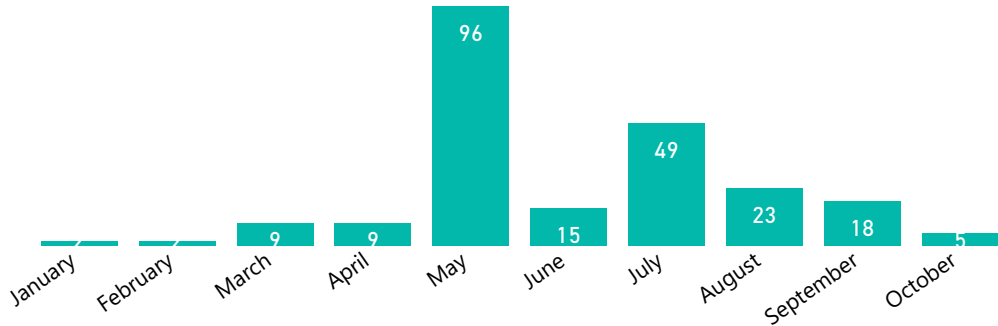

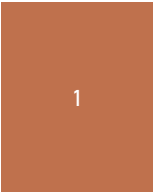
